Delayed distribution would lead to denial of refund.

#### CC Vs SAIL 2020-TIOL-88-SC-CUS

The Supreme Court has held that the cost of post importation activities in a project import, which are not mandatorily provided by the supplier of import goods, is not includible the assessable value of imported goods.
