



GSTR1 Return Filing Trend (July 2017- May 2020)









Invoice Count as per Turnover Slabs (at GSTIN Level)
















Modes of E-way Bill Generation

Modes of E-Way Bill Generation




Modes of Goods Transport (In Terms of Count)














GSTNs YouTube Channel 2017 – 2020






