Manufacture of Dies for foreign customer and retaining them for further use - Shall be intra-state supply and will not qualify as export.

Catering Service to Educational Institutions is exempt and hence there is no need to deduct TDS.

| 43 | 16.05.2020 | Section 128 of Finance Act, 2020 in order to bring amendment in Section 140 of CGST Act w.e.f. 01.07.2017 has been notified to take effect from 18.05.2020. The said amendment empowers the Government to prescribe time limit for availing transitional credit. |









# **NEWS**

Centre gives Rs. 15, 340 crores as GST compensation to states. In 2019-20, the Centre had released Rs 1,20,498 crores GST compensation to states while it had collected only about Rs 95,000 crore in the form of compensation cess.



Corona cess on liquor to stay for now in Delhi. HC refused to stay 70% special corona fee on the MRP of liquor.



The TN State Government has promulgated the Tamil Nadu Goods and Services Tax (Amendment) Ordinance, 2020 amending the Tamil Nadu Goods and Services Tax Act, 2017 (Tamil Nadu Act 19 of 2017) to extend due dates for various compliances due to Coronavirus pandemic.







# CUSTOMS DUTY EXEMPTION FOR COVID-19 MEDICAL EQUIPMENTS

To fight COVID pandemic, Customs Duty and Health Cess on medical equipments, namely ventilators, face or surgical masks, personal protection equipment (PPE), COVID testing kits and inputs for manufacturing such items were exempted. Inputs thus made available at lower cost would also boost domestic manufacturing of such medical equipments.

Sale of book cannot be bundled along with coaching and training service. The books are standard books and available for sale to anybody. Hostel facility also cannot be bundled with coaching service as it is not a general practice to provide such hostel facility.
